TEXECUTIVE DIRECTOR REPORT:

- HAGC WAS CONTACTED BY RCGC (ROWAN COLLEGE AT GLOUCESTER COUNTY) TO PARTICIPATE IN A PROPOSED SPECIAL NEEDS HOUSING DEVELOPMENT ON THE ED'S AND MED'S CORRIDOR. HAGC WOULD POTENTIALLY MANAGE THE UNITS AND RECEIVE A FEE. THE PROPOSAL IS BEING REVIEWED REGARDING FEASIBILITY; HAGC WOULD NOT CONTRIBUTE ANY DEVELOPMENT FUNDS OR PRE-DEVELOPMENT EXPENSES.
- THE HOUSE APPROPIATIONS COMMITTEE RELEASED THE T-HUD FUNDING BILL BUDGET PROPOSAL FY2020. VOTING BY THE SUB-COMMITTEE WILL BE CONDUCTED TOMORROW (MAY 23RD) IT INCLUDES OVER \$50.1 BILLIONS FOR HUD PROGRAMS, A PROPOSED INCREASE OF \$5.9 BILLION ABOVE THE ENACTED LEVEL FY2019. DETAILED AMOUNTS ARE INCLUDED IN YOUR PACKETS.
- COMMISSIONERS MAY HEAR NEWS REGARDING PROPOSED CHANGES TO REGULATIONS ON IMMIGRATION POTENTIALLY AFFECTING THE WAY HUD ASSISTANCE IS CALCULATED. CURRENT REGULATION INDICATES THAT ASSISTANCE TO A HOUSEHOLD THAT CONTAINS UNDOCUMENTED INDIVIDUAL(S) IS TO BE PRORATED, AS TO NOT UTILIZE HUD FUNDS ON BEHALF OF SAID PERSON(S). THE PROPOSED RULE IS BEING REVIEWED AND PUBLICLY COMMENTED ON BY INDUSTRY GROUPS FOR POTENTIAL LANDLORD RESPONSIBILITIES THAT MAY NOT HAVE BEEN THOROUGHLY CONSIDERED.
- HUD CONDUCTED AN IN-HOUSE FINANCIAL MANAGEMENT REVIEW FOR THE 2018 HCV PROGRAM. THE PERIOD REVIEWED SPANNED FROM DECEMBER 2016 THRU MAY, 2018. THE RESULTS INDICATED NO FINDINGS OR ACTIONS NEEDED, FINANCE DIRECTOR GRACE SEENEY AND HER STAFF WERE ABLE TO PROVIDE ALL NECESSARY INFORMATION AND THE REVIEW WAS CLOSED OUT WITHOUT INCIDENTS.

- ALL OF THE NANCY ELKIS BUILDING'S WALKWAY ENTRANCES HAVE BEEN REPLACED WITH FRESH CONCRETE. AHO DIRECTOR LETIZIA AND HIS STAFF FACILITATED A SMOOTH PROCESS IN IMPROVING THE BUILDING.
- IT WAS PREVIOUSLY REPORTED THAT THE DOMESTIC HOT WATER TANK AT COLONIAL PARK WAS LEAKING. WE HAVE CONTRACTED G-MECHANICAL FROM VINELAND, AS IT WAS DETERMINED THAT THEIR PROPOSED SOLUTION WAS THE BEST WAY TO PROCEED AT THIS TIME.
- PAYROLL FOR THE WEEK OF JULY 29TH WILL BE THE FIRST TIME HAGC USES THE FLEX SYSTEM. CURRENTLY, WE USE A PORTAL THAT CAN ONLY BE ACCESSED BY USING ONE OF TWO COMPUTERS ALLOWED, THE NEW SYSTEM CAN BE ACCESSED FROM ANY LOCATION THRU A SECURE NETWORK. THE CHANGE WAS DUE TO AN INCIDENT ABOUT A MONTH AGO, WHERE THERE WAS A NEIGHBORHOOD WIDE INTERNET BLACKOUT AND PAYROLL HAD TO BE COMPLETED VIA PHONE.
- SHEPHERD'S FARM BOARD WILL MEET ON JUNE 12^{TH;} MEETINGS FOR THIS ENTITY ARE NOT REGULARLY SCHEDULED.
- THE NANCY ELKIS BUILDING IS LOCATED ON A DESIGNATED OPPORTUNITY ZONE; HUD IS PROVIDING INCENTIVES TO THOSE WHO WOULD BE INTERESTED ON REFINANCING THEIR MORTGAGES THRU HUD AND ARE LOCATED WITHIN THESE ZONES. INTEREST RATES ARE DOWN, POTENTIALLY REDUCING THE INTEREST BY 2/3. FINANCIALLY THIS COULD BE ADVANTAGEOUS; HOWEVER OTHER PROGRAM REQUIREMENTS WOULD HAVE TO BE EVALUATED AS WELL.
