## **DEXECUTIVE DIRECTOR REPORT:**

RESOLUTION #19-31: CONSIDER RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT FOR LEAD BASED PAINT RISK ASSESSMENT, INSPECTION & CLEARANCE EXAMINATION- SCATTERED SITES

SPECIFIC INSTRUCTIONS WERE GIVEN FOR THIS GRANT AND APPROVALS HAVE NOT BEEN RECEIVED AS OF YET. THIS CONTRACT IS BEING AWARDED BECAUSE OF A GRANT AND WE HAVE TO ENTER INFORMATION INTO THEIR PORTAL IN TERMS OF A BUDGET. HUD HAS TO KICK IT BACK TO THE FIELD OFFICE LEVEL AND WE NEED TO WAIT FOR OUR APPROVALS. WE WILL NOT SIGN AND APPROVE THE RESOLUTION UNTIL WE HAVE ALL OF HUD APPROVALS.

<u>COMMISSIONER KINTZING:</u> IS THE GRANT COVERING THE WHOLE COST? <u>ED GOBER</u>: YES, WE WERE APPROVED FOR THE LEAD BASED PAINT GRANT.

- WE DO NOT HAVE ANY BUDGET NUMBERS AS OF YET. WE JUST RECEIVED INFO TO PREPARE OUR OPERATING SUBIDY CALCULATION RELEASED ON MARCH 19 AND THE TURN AROUND TIME IS APRIL 9. THE RESOLUTION IN THE PACKET IS FOR THE PUBLIC HOUSING PROGRAM. WE ARE STILL OPERATING ON LAST YEAR NUMBERS.
- THE SAME IS TRUE FOR THE VOUCHER PROGRAM IN TERMS OF HAP FUNDING AND THE ADMIN FEE FUNDING. IT HAS NOT BEEN IDENTIFIED HOW MUCH WE WILL BE

RECEIVING. WE ARE OPERATING ON WHAT WE RECEIVED LAST YEAR. WE DON'T KNOW THE PRORATION YET. WE ARE OPERATING IN THE DARK.

• <u>COLONIAL PARK:</u> A LEAK HAS BEEN DISCOVERED IN THE HOT WATER TANK. WE FEEL THE BEST WAY IS TO MAINTAIN A HOLDING TANK, MAYBE TWO TANKS. THE CURRENT TANK WAS INSTALLED BEFORE THE BUILDING WAS BUILT. <u>CHAIRMAN BAIN</u> STATED PREVIOUSLY BUILDERS BUILT THE BUILDING AROUND THESE "HEAVIES" AND NOW IT WOULD HAVE TO BE TAKEN APART PIECE BY PIECE TO REMOVE IT FROM THE BUILDING.

ED GOBER VOICED THAT PAUL LETIZIA, AHO DIRECTOR, IS WORKING ON RECEIVING QUOTES AND WE ARE TRYING NOT TO DISPLACE THE RESIDENTS.

PAUL LETIZIA ADDED THAT THEY WOULD HAVE TO SPECIAL- MAKE THE TANK TO REPLACE THE ONE THAT IS IN THERE AND THEN THEY CANNOT GET IT IN THE BUILDING. HE IS STILL WORKING ON QUOTES. THE CURRENT TANK HAS A HEAT BUNDLE IN IT. WE DON'T KNOW THE DISPLACEMENT TIME AS OF YET. HE WOULD LIKE TO STAY AWAY FROM THE INSTANT HOT TANKS. PAUL IS HOPING THE CUT-OFF TIME WOULD ONLY BE A DAY WITH NO DISPLACEMENT.

<u>CHAIRMAN BAIN</u> OFFERED THAT WE ARE TAKING OUR TIME TO GET THE BEST DECISION. OUR STAFF KNOWS THE RAMIFICATIONS OF THIS AND WE NEED THE BEST CASE SCENARIO.

<u>PAUL LETIZIA:</u> IN HOUSE, WE TOOK THE COVER OFF OF THE TANK AND REALIZED THE EXTENT OF THE CORROSION. IT IS 40 YEARS OLD.

- THERE IS A NEW PRINCIPAL DEPUTY ASSISTANT SECRETARY OF PUBLIC & INDIAN HOUSING –<u>R. HUNTER KURTZ.</u>
- THE PRESIDENTS CURRENT BUDGET SLASHES OUR PROGRAMS. THE LAST FEW YEARS, THE PRESIDENT HAS SLASHED OUR PROGRAMS AND WHAT HE PROPOSES DOES NOT COME INTO FRUITION. ED GOBER ADVISES THE COMMISSIONERS TO ADVOCATE. THE CHAIRMAN AND ED KIM GOBER WILL BE GOING TO WASHINGTON ON APRIL 7-9 TO ADVOCATE TO SENATOR MENENDEZ AT THE NAHRO CONFERENCE.

<u>CHAIRMAN BAIN</u> STATES THAT WE HAVE A PULPIT AND WE WILL DO WELL IN THE CONGRESS CAUCUS BUT THERE WILL BE PROBLEMS ON THE SENATE SIDE. IN WASHINGTON WE HAVE SOMEONE WHO IS RUNNING OUR AGENCY THAT DOES NOT HAVE A CLEAR UNDERSTANDING ABOUT HOUSING AND HE IS NOT TAKING DIRECTION FROM THE PEOPLE IN THE KNOW BUT TAKING DIRECTION DIRECTLY FROM THE TOP.

<u>COMMISSIONER SMITH</u> SUGGESTS HAGC CONTACT THE NEWSPAPERS TO GET THE WORD OUT AND REQUEST A SERIES OF ARTICLES ABOUT HOW THE CURRENT
