## **TEXECUTIVE DIRECTOR REPORT:**

- E. D. Gober informs the Board that invitations will be going out soon for the 50<sup>th</sup> Anniversary celebration. We have arranged for buses to transport residents from Carino, Shepherd's Farm and Colonial Park. There will be a photographer. Commissioners should please RSVP to Nelly Rojas. We hope to close to the public 11am-3pm, so employees can attend the celebration. Motion made and passed.
- E. D. Gober has been appointed as a trustee for PHADA. There will be a retreat in Houston, Texas on Oct 17-20. The purpose of the meeting is to determine direction of organization since COVID has changed the housing market and the way we do business.
- There are 2 articles in the packet about the housing crisis. People with vouchers are having lots of trouble finding housing all over the country, not just in Gloucester County.
- HAGC was awarded 30 mainstream vouchers which will arrive in November. For these vouchers, a member of household must be disabled (non-elderly). It does not need to be the head of the household, just a member such as a disabled child.
- Move to Work application was submitted in a timely manner. Have not heard back from HUD yet.
- E.D. Gober indicates we have scheduled a special meeting on Sept 21 for the FSS action plan and the agency plan. This will be a public hearing. The regular board meeting will still take place on Sept 28. We needed the special meeting prior to Sept 28 deadline to make the deadline to submit the FSS action plan to HUD to qualify for the coordinator grant.
- E.D. Gober explained the state issued their GASB68 report. We received the 2021 liability for the housing authority. It is around 4.2 million. In 2020 it was 5.6 million. These are estimates. This is one of last two pieces that the auditors need to get the audit to HUD by the deadline of Sept 30. The last piece will be the OPEB liabilities and there is an agenda item to expand the OPEB report to evaluate the expense and liability to 2018.
- HAGC met with McKernan architects. We want some changes to the plans. Hopefully this is the last meeting before going out to bid.
