■DIRECTOR'S REPORT –2017

- * Executive Director Kimberly Gober reported that she, the Human Resource Manager Elida Ortiz, and Jeff Daniels, Esq. have met with Hardenberg and IAA Insurance. (The current Health Insurance Providers). HAGC is still projected to save another \$90,000 over the State of NJ Health Insurance. It is recommended to stay with this plan rather than to go back to the State of NJ Health Insurance. A packet will be mailed to all the Commissioners. The Chairman and Commissioners are in agreement to keep the current plan.
- ❖ HAGC continues operating under financial uncertainty since it is operating under a continuing Resolution. There still is not a final budget for 2017. Industry groups suggest operating under current levels received in 2016, which continues until April 28th 2016.
- We are evaluating, along with the new administration, a Smoke Free Environment.

- Chairman Bain offered that there is a new secretary for HUD, Ben Carson M.D., putting the HAGC in limbo right now. No one knows where the new administration is headed.
- Financial Reports were emailed. In looking at all entities, there was a 3.4 million dollar loss. There is a \$741,000 expense for other postemployment benefits, which is accrued. That number was also subject to an Actuarial Evaluation. GASB68 is estimated because the State has not published the final numbers for 2016. HAGC followed the same expense as for 2015. In the operating statement, there is a \$440,000 estimated expense for GASB68. There is \$2.6 million for depreciation. Those 3 numbers come to a total of \$3.7 million. From a cash perspective, there is \$300,000 to the positive. Accountants want accruals on the company's financial statement. This is necessary to have an unqualified audit. In a utopia, we should be putting cash away, but that is just not possible in the fiscal environment in which we operate. Commissioner Brendan Garrozzo commented that the days of cash on hand do not exist in this environment. Executive Director Kim Gober stated this report is the HAGC end of year. Grace Seeney reported there is still an adjustment for GASB68 and adjustments for FDS (the financial data schedule).
