Carson, the incoming Secretary of HUD, reports he does not have any housing credentials. Kim Gober included a letter from John Boehm about Dr. Ben Carson in the packet.

- VASH Vouchers: 10 have been referred of the 19 we have. The applicants are referred through the VA. We currently have 2 vets in the Nancy J. Elkis Building. Commissioner Smith inquired if the private sector can do anything to help vets that don't have any housing yet. Kim Gober offered that a letter has been sent to our landlords to let them know we have these vet vouchers. Commissioner Smith requested HAGC send a letter to landlord Bill DiAsentis. Executive Director Gober stated she will provide Commissioner Smith with a landlord packet for Mr. DiAsentis.
- Audit for Shepherd's Farm has been completed. The Audits for the remaining entities have begun.
- Resolution HR 20208 has been extended through April 2017. This means we are funded at 2016 levels. We still don't know what our budget is for 2017.

Commissioner Kintzing arrived at meeting: 4: 35 PM

- The Intake staff is working overtime, slowly increasing the leasing in the Voucher Program. This is a tedious process because most of the time we are dealing with applicants who cannot provide paperwork.
- Section 8 is working overtime, having 3 employees out during the summer and fall. We have hired one to replace the processor who left with a retirement disability, one is back to work and one processor will be back on January 17th. The tenant processor position is very intricate. You cannot hire a temp for this job.
