## **TEXECUTIVE DIRECTOR REPORT:**

- E. D. Gober informed the Board that there were substantial emergency repairs made at Carino Park due to water damage caused by a resident washing clothes in the bathtub. Most of the repairs were done in house which proved very cost effective. Residents were placed in hotel for a week while repairs were completed.
- E. D. Gober advises the Board that we are making an application to the Moving to Work (MTW) program offered by HUD. This program may be re-named "Local Innovative Solutions". The advantage to the housing authority is the designation of funds can be co-mingled, giving the authority more flexibility to address financial needs. Also, the authority can request wavers from HUD to better serve our populations. A Public hearing was held on July 8, 2022. The RAB was very supportive of this initiative. We also had enthusiastic approval of our participation in this program from Continuum of Care of Gloucester County. Resolution 22-71 provides authorization to submit the application.
- HUD has made several changes to the Family Self-Sufficiency program (FSS) guidelines. We need to formulate a new action plan to meet these guidelines and may require a special meeting to approve the plan and submit within the HUD deadline of September 30, 2022. E.D. Gober will work closely with Chairman Bain to meet this deadline. If we do not apply by Sept 30, we cannot apply for the FSS grant which last year was \$110,000.00.
- Harmony Gardens is the name of the new construction taking place in Glassboro. GHA and Pennrose
  are partnering on this project. They are hoping to open in October. All of the units have project-based
  vouchers. Applications opened on July 1. We have 134 applications. Units are for 55 and older with 17
  units designated for special needs. Thirteen of the 17 special needs units do not have age restrictions.
- Some banks have been added to the annual agenda. When investment funds become available, we want the flexibility to purchase CDs or Money Market accounts with the most competitive rates. Operating accounts will remain with Hud affiliated banks.
- The Rowan College project is now called Residents at South College Drive. This is a Special needs project.
- We needed a new booster pump at Carino Park. Paul reported that is being installed today.
- Commissioner Scott Kintzing praised the integrity and strength of the listed banks in the new resolutions.
