A Regular Meeting of the Housing Authority of Gloucester County was held in the Joseph A. Reed Board Room, Nancy J. Elkis Building, on Wednesday, November 16, 2022 beginning at 4:30 P.M.

EXECUTIVE DIRECTOR REPORT:

- E.D. Gober shares with the Commissioners with great sadness the passing of former Commissioner Betty Jane Purnell on August 10, 2022. Former Commissioner Purnell proudly served HAGC's organization for 20 years.
- E.D. Gober indicates the Housing Authority of the Borough of Glassboro's (GHA) project, Village of Harmony Garden, will soon start lease-ups. The builder suggests that turnover of all the units will happen all at once at the beginning to mid-December. The application list is currently open, and individuals will soon be contacted to determine eligibility for vouchers. GHA has a partnership with Pennrose Properties, Pennrose will start the leasing and GHA will review the files to certify voucher issuance. A scheduled walk through for punch list items will soon be performed.
- E.D. Gober informs that regarding staff, HAGC is short a Tenant Interviewer/Investigator (TII) and after conferring with the Personnel Committee, it is supported that HAGC hire two part-time TII staff members. Also, in conjunction with HAGC's new security program, we want to hire two additional part-time Security Guards. HAGC would like to have more Security Guards available to provide more coverage with the new security program. An in-house applicant was hired as HAGC's new Security Supervisor. Our applicant has prior experience in a security capacity with a Housing Authority. HAGC will also look to fill this applicant's previous job position. The security room is about 90% operational and Life Station contracts have been executed. The internet service contracts were executed following the September Board Meeting. IT Director Alma Asllanaj informs that internet service should be operational at all sites by December 15, 2022, and HAGC will then coordinate with Life Station. Also, AHO Department will have electric strikes installed on the doors to each security office to permit access for EMS and also have electric strikes installed on the exterior doors to provide lockdown capability. The remote access will be from the Security Operations Center in Colonial Park.
- E.D. Gober indicates with the RCSJ project that HAGC met with McKernan Architects, Development Consultant Rick Ginnetti, Gloucester County and the College for a review of the plans and concept. The County and College have given HAGC the greenlight to proceed with the next phase for bids.
- E.D. Gober explains RES 22-107, 22-108, and 22-109 respectively are recommending Angelini, Viniar and Freedman for Primary Counsel, Brown and Connery for Secondary Counsel, Bowman and Company for Audit Services, and The Brooke Group for Housing Development Consultant. Also, RES 22-110 regards voiding outstanding checks and distribute unclaimed funds to the State. RES 22-111 proposes a change to the Section 8 Administrative plan, HAGC has been operating under a waiver that will expire at the end of this year to permit voucher holders searching for housing additional time. Regulations permit 60 days then an additional 60 days can be requested, also HAGC has always provided an additional 30days for a disabled individual as a reasonable accommodation, this resolution will permit HAGC to still allow the additional search time for voucher holders. RES 22-112 involves closing out HAGC's capital funds program for the listed grant year.
